# OBTAINING A TRESPASS AGREEMENT

Any home or land that is vacant due to being unoccupied, condemned, damaged from fire or etc., 24 hours 7 days a week can complete a TRESPASSING AGREEMENT. The Trespasing Agreement will cover the home, shed and vacant land surrounding the property.

1. Post two "No Trespassing" signs on the property; preferably on the front and rear doors.

2. Photograph all signs posted and inform **Officer Sanders by calling 910.433.1846.**

3. Lastly, the owner/agent needs to fill out a Trespassing Agreement form.

## TRASH REMOVAL

Items deemed as trash or health risks should be disposed through the following ways:

1. Fyfixit App

2. Request for curbside pick-up through Fayetteville's city website or call 910.433.1329

3. Emergency pick-up can be requested through dispatch by any city department

# FIRST DEGREE VS. SECOND DEGREE TRESPASS OFFENSE

## FIRST DEGREE TRESPASS OFFENSE

An individual who is guilty of 1. Entering/remaining without authorization

2. Being on the premises of a secured building/land without permission.

## SECOND DEGREE TRESPASS OFFENSE

An individual who is guilty of 1. Entering/remaining without authorization

2. Being on the premises of a secured building/land without permission.

3. Remaining on a premises even after being notified to leave by the owner, on individual in charge of the premises, by lawful occupant, or by another authorized person.

4. Disregarding posted signage, that notifies individuals not to trespass.

# COMPLIANT & NON-COMPLIANT INDIVIDUALS

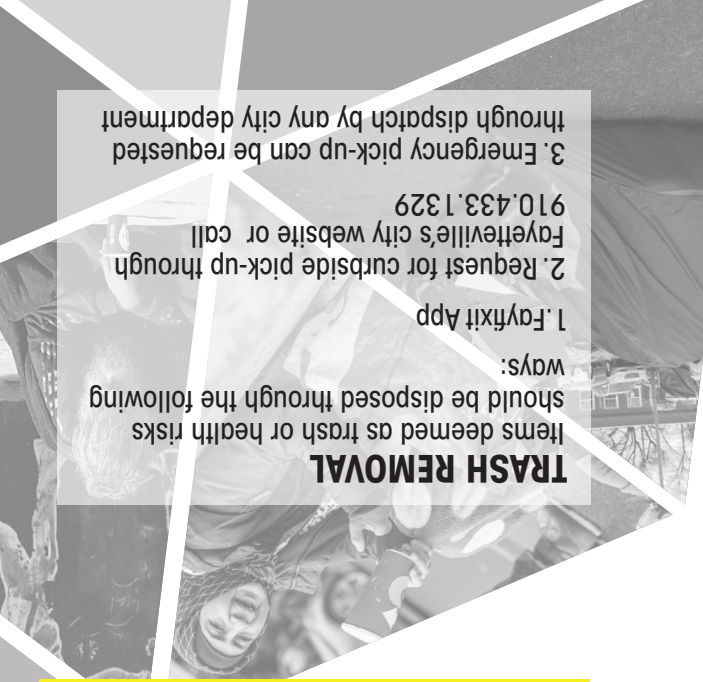
## COMPLIANT INDIVIDUALS

will simply remove their items and themselves from the property.

## NON-COMPLIANT INDIVIDUALS

will respond in opposition. They will not leave when asked and may have to be arrested for violating North Carolina's Laws.

Both of these types of individuals can be referred to the various resources available in Fayetteville, North Carolina. However, as prior stated, if the individual is identified to have been non-compliant, then they will most likely be arrested due to violating NC's laws.
