



# Internship Program

We are proud to announce the Spring Internship Program for the Fayetteville Police Department. This is a paid internship that will allow students to work 25-35 hours per week for the semester from February 14 – April 29, 2022. There will also be an opportunity for a Summer 2022 Internship.

To qualify, applicants must be:

- A current student at any college or university (but you must be able to be commute to be on site daily for the duration of the internship).
- 18 years of age or older.
- Must not have been convicted or pled guilty/no contest to a felony or any offense that would be considered a felony if committed in the State of North Carolina.
- Must not have been convicted of a misdemeanor of a serious nature that reflects moral turpitude or indicates a tendency to disregard the law.
