Mr. Mark Brown, PWC, Customer Services Director, presented this item and stated the Fayetteville Public Works Commission, during their meeting on January 26, 2022, approved the bid recommendation to award the contract for the Readvertisement for the Annexation Phase V, Project XV, Construction Area 32 East, Section I, to T. A. Loving Company, Goldsboro, NC, the lowest responsive, responsible bidder, in the total amount of \$14,735,075.00 and authorized staff to forward this recommendation to City Council for approval.

Bids were received on December 8, 2021, as follows:

- J. Smith Civil, LLC, Goldsboro, NC\$13,155,618.20
 T. A. Loving Company, Goldsboro, NC\$14,735,075.00
- Notice of the bid was advertised through PWC's normal procedures on October 15, 2021, with an initial bid opening date of November 16, 2021. Addendum No. 1 was issued on November 11, 2021, in part, to extend the bid opening date to November 24, 2021. PWC did not receive the requisite three (3) bids. Notice of the bid readvertisement through PWC's normal procedures occurred on November 24, 2021, with a bid opening date of December 8, 2021. PWC received two (2) bids, which were timely opened and evaluated by PWC Water Resources Engineering for this project.

PWC staff requested interviews of the references submitted by the lowest bidder, J. Smith Civil, LLC. After evaluation of the reference interviews, bid, and prior performance of the contractor, PWC staff

determined that J. Smith Civil, LLC was a non-responsible bidder for the size and scope of this project. PWC staff then requested interviews of the references submitted by the second lowest bidder, T.A. Loving Company. After evaluation of the reference interviews, bid, and prior performance, PWC staff concluded that T.A. Loving Company was the lowest responsive, responsible bidder for this project. It is therefore PWC staff's recommendation to award this project to the lowest responsive, responsible bidder, T.A. Loving Company, Goldsboro, NC.
