Council Member Gonzalez expressed concern that the offer to purchase was only 70% of the tax value. Mrs. McDonald advised acceptance of offers to purchase have varied in the past from 60% to 100% of tax value for private citizens and less for nonprofits wanting to build low to moderate income housing.

MOTION: Council Member Gonzalez moved to decline the offer to purchase two vacant lots on Vanstory Street.

The motion died due to lack of a second.

MOTION: Council Member Bates moved to approve the offer to purchase two vacant lots on Vanstory Street.

SECOND: Council Member Williams

VOTE: PASSED by a vote of 8 in favor to 2 in opposition (Council Members Evans and Gonzalez)

2.J. Approve the rezoning from R6 residential district to C1 commercial district or to a more restrictive zoning classification for property located west of Strickland Bridge Road and south of Graham Road. Containing 2.00 acres more or less and being the property of Rodger and Letha Pierce. Case Number P07-70F.

Council Member Worthy requested a public hearing so citizens could have an opportunity to express their concerns before City Council. Council Member Gonzalez concurred.

Council Member Williams offered comments in opposition to setting a public hearing.

MOTION: Council Member Worthy moved to set a public hearing on December 17, 2007.

SECOND: Council Member Gonzalez

VOTE: PASSED by a vote of 9 in favor to 1 in opposition (Council Member Williams)

3. PUBLIC HEARINGS

A. Consider an application by Crawford Design Company for a Special Use Permit to allow automobile off-street parking for uses not allowed in the R6 residential district for property located at 2718 and 2722 Arlington Avenue. Containing .688 acres more or less and being the property of N&B Company, LLC. Case Number P07-63F.

Mr. Garner, Planner, showed a vicinity map and gave an overview of the current land use, current zoning, surrounding land use and zoning, and 2010 Land Use Plan. Mr. Garner stated a previous rezoning request was denied and the applicant now seeks a Special Use Permit for commercial parking. Mr. Garner stated the Zoning Commission recommends denial of the Special Use Permit. Mr. Garner responded to questions and provided further clarification as requested by Council.

This is the advertised public hearing set for this date and time. The public hearing opened at 7:50 p.m.

David R. Nimocks, III, 2709 Breezewood Avenue, Fayetteville, NC 28303 appeared in favor and provided an overview of the Terminex business and the need for additional parking due to growth and expansion.

Del Crawford, 914 Hay Street, Fayetteville, NC 28301 of Crawford Design Co. appeared in favor and stated there would be no evidence of a parking lot on Arlington Avenue because of the landscape, buffers and ingress/egress from Breezewood Avenue.

Lois Condlin, 2711 Arlington Avenue, Fayetteville, NC 28303 appeared in opposition and expressed concern that the lights installed in the parking lot would shine in her windows and backyard.

Mildred S. Sibbett, 2707 Arlington Avenue, Fayetteville, NC 28303 appeared in opposition and expressed concern about the cutting of trees because they provide a buffer for noise and lights. Tom Smith, 2710 Arlington Avenue, Fayetteville, NC 28303 appeared in opposition and expressed concern that the cutting of trees and installation of a parking lot would negatively impact the neighborhood.

Tony Morgan, 2719 Arlington Avenue, Fayetteville, NC 28303 appeared in opposition and expressed concern about being able to hear employees while they are outside taking their work breaks.

Steve Crumbley, 2731 Arlington Avenue, Fayetteville, NC 28303 appeared in opposition and expressed concern that the quietness of the neighborhood would be lost.

Lisa Hasttaler, 2706 Arlington Avenue, Fayetteville, NC 28303 appeared in opposition and expressed concern that the otherwise quiet and peaceful street could be headed for a downward spiral.

Scott S. Tope, 2727 Arlington Avenue, Fayetteville, NC 28303 appeared in opposition and stated expanding businesses can relocate to other areas that won't negatively impact residential neighborhoods.

William B. Kirby, Jr., 2723 Arlington Avenue, Fayetteville, NC 28303 appeared in opposition and expressed concern that special use permits circumvent the city's zoning policies and stated parking lots do not belong in residential neighborhoods.

Mayor Chavonne asked if there was interest in further discussion between the opponents and proponents.

There was no interest expressed and the public hearing closed at 8:15 p.m.

MOTION: Council Member Bates moved to deny the Special Use Permit as recommended by the Zoning Commission.

SECOND: Council Member Worthy

Council Member Williams thanked Terminex for its contributions to the community. Council Member Gonzalez spoke to residents protecting their neighborhoods and asked why the applicant requested a Special Use Permit. Mr. Garner responded current zoning ordinances allow requests for Special Use Permits.

VOTE: PASSED by a vote of 9 in favor to 1 in opposition (Council Member Williams)

B. Consider the rezoning from P3 professional district to R5 residential district\conditional zoning to allow 68 residential condominiums for property located at 5583 Morganton Road. Containing 2.77 acres more or less and being the property of William Maxwell. Case Number P07-68F.

Mr. Garner asked to reserve his presentation since the applicant had officially withdrawn the rezoning request. Consensus was to set aside the presentation and move forward with the publicized public hearing.

This is the advertised public hearing set for this date and time.

The public hearing opened at 8:25 p.m.

No one appeared in favor.

Ed Blanchard, Jr., 5444 Summer Duck Road, Fayetteville, NC 28304 appeared in opposition and made a presentation regarding his concerns for the protection of wetlands in the McFayden Lake area.

There was no one further to speak and the public hearing closed at 8:42 p.m.

MOTION: Council Member Bates moved to deny the rezoning based on the request from the applicant.

SECOND: Council Member Kirby

Council Member Gonzalez spoke in favor of suspending further construction in the area. Dale E. Iman, City Manager, explained there are no current projects for McFayden Lake and additional stormwater ordinance improvements are forthcoming. Council Member Worthy noted the Department of Energy and Natural Resources (DENR) takes care of wetland areas.

VOTE: UNANIMOUS (10-0)

C. Consider an application by Moorman Kizer and Reitzel for a Special Use Permit for mini-storage warehouses in a C1P commercial district for property located at 2618 Legion Road. Containing 2.02 acres more or less and being the property of Rorie Investments, Inc. Case Number P07-71F.

Mr. Garner showed a vicinity map and gave an overview of the current land use, current zoning, surrounding land use and zoning, and 2010 Land Use Plan. Mr. Garner stated the owner of the property wishes to add additional storage units to the Mini-Maxi Storage facility, an existing mini-storage business on Legion Road. Mr. Garner stated the Zoning Commission recommends approval of the Special Use Permit with conditions.

This is the advertised public hearing set for this date and time. The public hearing opened at 8:50 p.m.

Jimmy Kizer, Moorman Kizer and Reitzel Engineers, 115 Broadfoot Avenue, Fayetteville, NC 28303 appeared in favor and stated the owner wishes to add additional storage and climate

control units to an already existing mini-storage business.

No one appeared in opposition and the public hearing closed at 8:51 p.m.

MOTION: Council Member Gonzalez moved to approve the Special Use Permit with conditions as outlined.

SECOND: Council Member Kirby

FRIENDLY AMENDMENT: Council Member Bates moved to approve the Special Use Permit with conditions as outlined and an additional condition that exterior lights face inward away from homes.

Council Member Gonzalez accepted the friendly amendment.
