7.1 Capital Project Ordinance Amendment-Change 2015-19 (Annexation Phase V-Areas 16 through 17 Capital Project Fund)

Budget Amendment No. 1 adjusts the estimates based on recent bids which include increasing the number of lots to be served per area above that originally estimated in the initial budget. This amendment also eliminates bond proceeds as a revenue source and is intended to be funded solely from the Annexation Reserve Fund.

7.2 Capital Project Ordinance Closeout 2015-1 (Automatic Vehicle Locators) and Capital Project Ordinance Amendment2015-20 (Computer Replacements)

To provide the additional funding for the MDC replacements, the funding from the previously approved AVL project (\$203,856.00) and Federal forfeiture funds (\$190,429.00) will be redirected to the computer replacement project.

7.3 Capital Project Ordinance Amendment 2015-21 (Cape Fear River Trail, Phase 2)

Capital Project Ordinance Amendment (CPOA) 2015-21 will appropriate additional funding to the Cape Fear River Trail, Phase 2 project, consistent with the supplemental municipal agreement with the North Carolina Department of Transportation (NCDOT) that was approved by Council on October 27, 2014. The supplemental agreement provided \$800,000.00 in additional state and Federal funding and revised estimated completion dates.

7.4 Capital Project Ordinance 2015-16 (Hazardous Materials Emergency Planning Grant)

The City has been awarded a \$7,650.00 grant to purchase training equipment for the Hazmat Regional Response Team from the Hazardous Material Emergency Planning Grant through the North Carolina Department of Public Safety, Emergency Management Division. There is no local match required.

7.5 Bid Recommendation for Underground Primary Distribution Cable awarded to HD Supply Power Solutions, Wake Forest, NC, the lowest bidder, in the amount of \$145,776.00.

This bid recommendation was for the purchase of 24,000 feet of 750 MCM AL underground primary distribution cable which is a regularly stocked electric inventory item. Bids were received October 21, 2014, as follows:

8.0 PUBLIC HEARINGS

8.1 Annexation of Ash Street

Ms. Karen Hilton, Planning and Zoning Manager, presented this item with the aid of a PowerPoint presentation and stated in June 2014, the City Council approved two annexation requests associated with the new Walmart Supercenter, which is being developed along Gillespie Street. The Walmart developer has requested that one more area be annexed. This small area is currently a platted but unopened street known as Ash Street. The developer plans to build a new entrance road along Ash Street in order to provide access to the Walmart. The developer would like for the City to maintain this street after it is built. In order for the City to maintain it, the new street will need to be inside the City. Thus, the developer has requested annexation. Staff recommends approval of the annexation request.

This is the advertised public hearing set for this date and time. There was no one present to speak and the public hearing was opened and closed.

8.2 Amendment to modify standards for fences under Section 30-5.D and related sections.

Ms. Karen Hilton, Planning and Zoning Manager, presented this item with the aid of a PowerPoint presentation and stated this amendment is part of an ongoing process to make the small adjustments that better align the development code with local conditions. There were no speakers at the public hearing on October 21, 2014, but staff and the Planning Commission agreed some additional changes were needed and scheduled a second hearing at which there was one speaker in favor. The Commission considered the revised draft on November 18, 2014, and recommended approval. Practical issues of maintenance of both fencing and landscaping triggered the proposed amendment. Staff also adjusted the placement--where in relation to the property boundary and required setbacks--the fence can be located. How to measure height of fences also was changed to address elevation differences between adjacent properties relative to the purpose of the fence. The amendment provided the opportunity to add standards for retaining walls and to clarify or expand the design options in return for more flexibility in location, particularly with regard to buffer fences.

Council Member Colvin asked what the position of the Planning Commission is. Ms. Hilton responded the Planning Commission is in agreement to approve this item.

This is the advertised public hearing set for this date and time. There was no one present to speak and the public hearing was opened and closed.

MOTION: Council Member Crisp moved to adopt the ordinance amending Chapter 30 of the Code of Ordinances of the City of Fayetteville to amend standards for fences under Section 30-5.D and related sections.

8.3 Code amendment to various sections of Chapter 30 to modify the HAO District boundary

Ms. Karen Hilton, Planning and Zoning Manager, presented this item and stated the changes proposed for the development code, Chapter 30, cover five topic areas. The following amendments are minor but substantive and address issues being encountered on a regular basis or make the Code consistent with other local or national actions:

- 1. Club/Lodge: Revises to the definition of this use to remove elements that are difficult to confirm and thus undermine the intent and regulation of the use.
- 2. Hospital Area Overlay (HAO) boundary adjustment: Reconciles the description in the Code with recent actions by the Zoning Commission and City Council.
- 3. Signs in medians: Restores a sign option historically available for private streets entering a subdivision and expands that option under certain limited conditions.
- 4. Utility trailers: Allows one single-axle trailer to be stored in front yard area when there is no access to a side or rear yard.
- 5. Central mailboxes: Integrates the relatively new US Postal Service requirements for central mailboxes in subdivisions.

The recommendation of staff and the Planning Commission is to approve these changes.

The changes being proposed in this amendment are part of an ongoing program to improve the fit with local conditions. The Planning Commission held a public hearing on November 18, 2014. There was one speaker signed up in favor, and the Commission invited comments from the other speaker present, who supported the changes. The Commission added the requirement that the trailer be placed on the driveway or an all-weather surface and recommended approval. The changes being proposed in this amendment are substantive but address issues being encountered on a regular basis in application of the development code.

There are no direct budget impacts. Some of the changes help small yard or handyman businesses and residential developers, and others help in code enforcement or maintaining stable neighborhood environments, thus strengthening the local economy and quality of life and associated revenues and growth.

MOTION: Council Member Mohn moved to pull amendment number 4, utility trailers, for a separate vote.

Council Member Arp asked Mr. Scott Shuford, Development Services Director, how the code enforcement would enforce this type of ordinance. Mr. Shuford stated staff will be monitoring that vehicles are parked on all-weather surfaces.

Council Member Jensen asked Mr. Shuford if there is currently a limit of how many trailers are allowed parked at a residence. Mr. Shuford responded the City does not have such an ordinance.

Council Member Colvin asked Mr. Shuford what other municipalities he had researched for this type of ordinance. Mr. Shuford responded staff had talked with Raleigh, Charlotte, Durham, and other large communities.

Council Member Hurst stated he had been contacted by residents that are upset regarding the amount of trailers their respective neighbors have parked in their yards.

Council Member McDougald asked if Council votes to deny item number 4, then residents would be permitted to park as many single-axle trailers as they want in their yards. Mr. Shuford confirmed that statement is correct.

Council Member Crisp asked if he has an authorized single-axle trailer that is registered with the Department of Motor Vehicles if he can park it in the street. Mr. Shuford responded that statement is correct.

Council Member Mohn asked the City Attorney if he could amend his motion or would he need a substitute motion. Ms. Karen McDonald, City Attorney, responded there could be a substitute motion or Council Member Mohn could withdraw his motion and make another motion.

Council Member Jensen asked Ms. Hilton if the ordinance pertained to cars. Ms. Hilton responded that the distinction is the current ordinance does address cars parked in yards, but does not address trailers parked in yards.

Discussion of street parking ensued.

Ms. McDonald recommended to table this item to the December 8, 2014, regular meeting and therefore allowing staff time to further research street parking.

Council Member Mohn withdrew his motion.

This item was moved to the consent agenda as Item 7.16 by Council Member Arp.

9.3 Street Repair Policy for New Utility

Mr.Rusty Thompson, Engineering and Infrastructure Director, presented this item with the aid of a PowerPoint presentation and stated the City of Fayetteville currently works with PWC for annexation projects to provide water and sewer to neighborhoods in the City. The current process used to repair the roadways from the utility installation is a permanent patch in the roads. This patch while acceptable does not improve the quality of the roads and has not been well received by the neighborhoods. We have attempted to respond to those concerns by

including an alternate bid for the projects which include a temporary patch and complete asphalt overlay near the completion of the project. To date the City has been able to select this option in four areas at an additional \$791,229.00 to the City. In addition, we do not charge our utility excavation and degradation costs related to annexation projects saving thousands of dollars in cost to the project. During the November work session, staff presented a street repair policy that would require installation of all new utilities in City streets be repaired with a temporary patch and complete overlay. Some positives with the proposed policy helps the City move the needle towards the benchmark of 85 percent of the roads being rated at 85 or better. We estimate this percentage would have a 5 percent improvement to our percentage over the next five years. Combining the enactment of this policy with our current resurfacing funding efforts would move us from 41 to 55 percent. This policy would increase the project costs differently on each project based on the size of the project and roadway conditions. Our City streets are one of our most important assets. The current conditions of our roads do not meet our benchmark of 85 percent of the roads to be rated at 85 or better. The current allowed method to use a patch for utility installations does not bring us closer to meeting the benchmark. The recent customer satisfaction survey showed that residents have expressed a level of dissatisfaction of the roadway conditions in the current and future areas for new utilities. To meet our citizen expectations, staff is proposing a new policy that would require the streets to be completely paved after utility work for new utilities has occurred within the City of Fayetteville's street system. Mr. Thompson concluded by stating this change would increase initial costs related to street repair and improve our benchmark while reducing our paving cycle.

Council Member Mohn asked if the proposed policy would apply to all utility companies that make new cuts in our roads. Mr. Thompson confirmed it would.

Council Member Arp asked if there is any provision for a small patch. Mr. Thompson stated this provision is addressed in Chapter 24 of the Code.

Council Member Colvin asked what Flowable Fill is. Mr. Thompson replied Flowable Fill is a multi-purpose fill material consisting of a blend of aggregate, cement, fly ash, water and admixtures. The mixture is designed to be fluid or flowing which allows it to fill the desired area without the need for tamping or compacting. Flowable Fill is also referred to as a "Controlled Low Strength Material" or CLSM.

Council Member McDougald stated he is pleased to see this policy and appreciates the work that staff has done on this item.
