## 5.0 ITEMS OF BUSINESS

#### 5.1 Resolution in Support of the Connect NC Bond Initiative

Mr. Theodore Voorhees, City Manager, introduced this item and stated the resolution is in support of a referendum for the sale of bonds as outlined by Governor McCrory in the Connect NC Initiative.

Mayor Robertson stated the Cumberland County Board of Commissioners adopted the resolution earlier today.

Council Member Crisp stated we need this, it all makes sense to let the folks in D.C. know we want this.

Council Member McDougald stated he had only just received the information and had not had any time to review the material.

Council Member Colvin stated this is an opportunity for an investment in our ports.

Council Member Wright stated he attended the Governor's presentation, which was very informative and interesting; we are in desperate need of broadening our infrastructure.

Council Member Crisp stated the information should have been distributed earlier to allow everyone the opportunity to study.

Council Member McDougald stated he did not see any reference to Murchison Road in the proposed improvements.

# 5.2 Ordinance Supporting Operation Safe Summer

Ms. Karen McDonald, City Attorney, introduced this item and asked the interest of Council.

Council Member Colvin stated he liked the draft ordinance, and further stated we need to get this right and we need to spend time on reviewing it and hash it out.

Council Member McDougald questioned the legality of requiring residents to register for house parties.

Council Member Crisp stated he regularly holds cook-outs at his home for 30 to 40 family and friends, and views this as an interference with the right to assemble in his home.

Council Member Jensen stated this item needs to be addressed in a future work session, and further stated we do not need to think about ourselves, we need to think about the kids; this is bigger than our opinions.

Council Member Wright stated he agreed the Council needs to put something in place.

Mr. Anthony Kelly, Assistant Police Chief, stated the goal is to protect the attendees at the house parties, the registration is not mandatory, it is voluntary.

Mayor Pro Tem Davy stated she would like to know how other municipalities are addressing this issue.

Council Member Hurst stated he also wanted to know how other municipalities are addressing this issue, and further stated this item needed to be further discussed at a work session.

Council Member Crisp stated we need to protect our children, but not infringe on the rights of adults.

Council Member McDougald stated curfews have been found to be illegal.
